# 9.1 Update on Ongoing Study of Bell Schedules

Chief Finance Officer Dave Montoya provided an update.

#### Board discussion included:

- Standardized grade-level start times are a goal for many.
- Potential models could push start times back 30 minutes for elementary and middle school.
- Middle school start times are currently early and can be hard on students/parents.
- Request was made to explore the impact on after-school activities.
- Recommendation was made to flip middle and high school start times to accommodate high school sports, employment and other extra curriculars.
- Some Board members stated that any start time before 8:00 a.m. is too early.
- Large gap between grade-level start times is hard on many families with children in both levels.
- PSD consultant will be asked to run more scenarios.
- Time frame for roll-out of bell schedule change was discussed.
- Continuity is critical for the community; whatever change is made should be long-term.
- Suggestion was made to extend bussing boundaries to reduce the number of students served.
- Discussion surrounding potential roll-out occurred.
- Important to engage parents in the process.
- High school students have the option to drive, walk or use the city bus; elementary students do not have that option.
- Board will not be able to please everyone with the decision.
- Will continue to explore efficiencies and study information provided by consultant.
