# 4.1 Transitions Pathways Update

Lead Assistant Superintendent Traci Gile, Chief Finance Officer Dave Montoya, Senior Executive Director of Student Services Liz Davis, Assistant Director of Integrated Services Aaron Vogt, and District Architect Brian Carnahan provided the update.

#### Board discussion included:

- Improvements could increase number of students served from 40/50 to 100/120.
- Clarification was provided on wash station/open bathrooms shown in design.
- Currently twenty-three students are served in the teen parenting program.
- CCAP funding has been frozen since March 2024.
- Data was requested on the number of teen parents and students currently unable to receive benefits of education due to funding.
- Gratitude was expressed for the hard work performed, collaboration, and proactive thinking for improvements and solutions to the program constraints.

# 4.2 CASB Presentation on Policy Governance

Matt Cook, CASB Director of Public Policy and Advocacy, presented Policy Governance to the Board members.

#### Board discussion included:
