Anna Lebedda expressed dissatisfaction with special education services provided by the district and asked the Board to offer services for students who do not currently have any opportunity.

Taylor Unwin informed those in attendance about the life expectancy of an autistic person, stated half of their life will be spent in school, and asked the district to ensure safety, dignity, purpose, and equity for people with disabilities.

Dani Lawrence expressed dissatisfaction with encrypted software used by the Integrated Services department, said it inhibits parent/student ability to participate and stated special education students are being denied benefits.
