#### 3.0 SUPERINTENDENT REPORT

Superintendent Kingsley introduced a video that highlighted various construction items completed across the district using 2016 bond funds, conveyed celebration on behalf of several schools, guided community members to mill levy information on the PSD website, provided information about mill levy updates and presentations from the finance department, and thanked first responders for efforts on the fire at Red Feather.

Anna Lebedda advocated for students with dyslexia and asked the board to consider missing data due to low participation in testing.

Fred Kirsch asked for transparency regarding the process for solar implementation in the district.

Charles Fitzpatrick spoke in support of solar energy in schools.

Taylor Unwin asked about Board member awareness of potential changes to the autism site-based programs at Bamford.

Dani Lawrence expressed frustration with graduation rates for ILS students and said the district is ignoring the needs of the ILS population.

#### 7.1 Mendez Barkis Renewal Contract

- Director Reed expressed concern about hiring a firm with potential split loyalties, and suggested the district hire a local lobbyist to head a district-run legislative committee.
- Board may not have time to make a change for current year because the legislative session will start soon.
- Can research other options for implementation next year.
- Important to demonstrate fiscal responsibility.
- Services provided by the current lobbyist were discussed.
- Possible coalition with other school districts will be reviewed.

Director Brokish moved that the Board determine that the Superintendent has reasonably interpreted Board of Education Policy EL 2.9 in his Internal Monitoring Report dated 9.24.24 and that the evidence presented supports the Superintendent's conclusions stated in the Internal Monitoring Report.

- Superintendent Kingsley maintains an incredibly busy schedule that includes frequent school visits and community engagement.
- Important to rebuild trust with community; Board holds partial responsibility for moving too fast on consolidation.

#### 7.3 Bamford Feeder Pattern Modifications

Vice President Zamora moved that the Board approve the change to Bamford Elementary School's feeder pattern so that students residing in the Bamford attendance area attend Preston Middle School for grades six through eight and Fossil Ridge High School for grades nine through twelve, and such that the boundary areas for Preston Middle School and Fossil Ridge High School change to include the Bamford Elementary attendance area beginning in the 2025-2026 school year.

Director Brokish seconded the motion.

#### Board discussion included:

- Assistant Superintendent Dr. Julie Chaplain provided the presentation.
- Gratitude was expressed for implementing Board feedback from previous meetings.
- ILS students will have the option to stay at Timnath MHS or move.
- Board asked for immediate solutions to overcrowding and staff delivered.

- Concern was expressed about socio-economic differences for some students who may not be able to stay at TMHS due to transportation difficulties.
- Families and students need stability; frequent school changes lessen the sense of security.
- Difficult to be nimble and stable in a huge system with varied immediate needs.
- Appreciation was conveyed to administration and staff involved with challenging work performed and completion of assigned task.

# 8.1 Budget Informational Item: Mill Levy and Bond Basics

Chief Finance Officer Dave Montoya provided the information.

Board discussion included:

- 27% of Total Program is cumulative for all traditional mill levy overrides.
- Mill levy overrides to not retire over time.
- Debt-Free Schools are a different type of override.
- Director Havelda reminded listeners of upcoming mill levy informational sessions.
- Funds from debt-free schools levy are kept in a separate fund.
- Oversight committee will monitor activities.
- Property taxes will increase \$25.00 per \$100,000 house value if mill levy passes.
- Gratitude was expressed for the thorough presentation.
